# B.A. ENGLISH SEMESTER III HISTORY OF BRITAIN-II B21HS02AN

#### INSTRUCTIONS FOR WRITING ASSIGNMENTS

Two sets of assignments are given for each course, the first set is descriptive and the second set is analytical. Each set of Assignments will consist of 5 (five) questions and learners shall choose any one from each set. Each Assignment carries 15 marks.

#### **General Instructions:**

- Begin with an introduction
- Explain the theory or idea supported by historical evidence
- Maintain clarity, style, structure and organisation throughout the assignment
- Provide a clear and concise conclusion
- Include a bibliography or references section at the end

- 1. Explore the impacts of the French Revolution on British literature and politics during the late 18th and early 19th centuries, considering how the revolutionary ideals and events across the channel influenced cultural and political discourse in Britain.
- 2. Examine the resistance and nationalist movements that arose in response to imperialism. How did colonised people fight against imperial rule and seek independence? Can you discuss the strategies and motivations behind these movements, as well as their impact on the broader colonial context?
- 3. Investigate how Romantic poets utilised language and form to convey intense emotions, evoke the grandeur of nature, and illuminate the complexities of the human condition. Also, discuss

the role of imagination in Romanticism, and explore how poets navigated themes of love, individualism, and spiritual longing in their works.

- 4. Discuss the portrayal of nature and the countryside in Victorian literature by analysing the works of John Clare and Alfred Lord Tennyson. How did Clare's pastoral poetry contrast with Tennyson's exploration of nature in the context of industrialisation and technological progress?
- 5. Compare and contrast the contributions of George Orwell and T.S. Eliot to both modernist and postmodernist literature. Analyse their thematic concerns, narrative techniques, and their impact on the literary movements of their time. Additionally, discuss the ways in which their writings reflect the shifting ideologies and uncertainties of the modern and postmodern eras.

What were the underlying motivations driving British initiatives to introduce the English language into Indian education, and how did they envision English education's impact on the socio-political structure of Indian society? Additionally, what were the anticipated outcomes of this language policy on Indian society?
- 2. How did the clash between the traditional 'Gurukula' education system and the colonial British educational agenda, influenced by the perspectives of Anglicists and Evangelicals, impact the evolution of education in India during the colonial era? Analyse the ideological, cultural, and socio-economic implications of this clash on the educational system and the broader society of colonial India.
- 3. How did traditional socialist ideologies interact with emerging ethical and Fabian socialism in late Victorian England? Analyse their different approaches to social change,

politics, and economic reform. Examine how these diverse perspectives influenced the British socialist movement within the cultural and political context of the time.

- 4. How did the principles of laissez-faire economic policy evolve in Great Britain during the 19th century, and what were the key factors that contributed to the gradual adoption of free trade policies? Analyse the shift from protectionism to free trade by exploring the philosophical background, legislative actions, and social movements that shaped this transition.
- 5. What were the driving forces behind the Cooperative Movement in Britain during the 19th century, and how did it contribute to social and economic transformation? Analyse the key principles, organisational structures, and significant milestones of the Cooperative Movement, and evaluate its impact on community empowerment, economic democracy, and the labour movement in Britain.
