Answer any five of the following questions in half a page each. Each question carries 4 marks.

1. Consider the following definition of Research:

Research is defined as the creation of new knowledge and/or the use of existing knowledge in a new and creative way so as to generate new concepts, methodologies and understandings. This could include synthesis and analysis of previous research to the extent that it leads to new and creative outcomes.

Comment on this definition based on your understanding of research. What can be added to this definition to make it better?

- 2. A friend of you who is an Engineer tells you that eating one Thulasi leaf a day will protect you from Corona. She tells that she has practiced it and found it effective. As a critical thinker, how will you react?
- 3. Suggest some areas of research that will contribute to societal progress and development of India.
- 4. A food company wants to assess the quality of their newly launched product. Briefly explain how can they do this using both qualitative and quantitative strategies.
- 5. Citing example of research you plan to do, explain how you can identify the knowledge gap.
- 6. Consider the following annotated bibliography (Sentences are numbered for ease of referencing in your answer).

Rajan S., 'Employee turnover and job performance: monitoring the influences of salary growth and promotion', Journal of Psychology, vol 113, no.1, pp. 56-64.: (i) In this article author reviews the influences of pay and job opportunities in respect to job performance, turnover rates and employee motivation. (ii) The author uses data gained through organisational surveys of companies in Kochi to try to identify the main causes of employee turnover and whether it is linked to salary growth. (iii) The research focuses on assessing a range of pay structures such as pay for performance and organisational reward schemes. (iv) The article is useful to my research topic, as author suggests that there are numerous reasons for employee

turnover and variances in employee motivation and performance. (v) The main limitation of the article is that the survey sample was restricted to mid-level management, thus the author indicates that further, more extensive, research needs to be undertaken to develop a more in-depth understanding of employee turnover and job performance.

- 7. In regions where a disaster occurs, (a) the task force seek information from the local community initially and proceed for further rescue measures. Briefly compare informal and formal methods.

**Original source:** The concern with 'cultures' which stimulated the ethnoarchaeological work grew out of a widespread disillusion in prehistoric archaeology with the value of describing and defining cultural entities and with the possibilities of interpreting them. It had become clear that cultures did not always equal ethnic units. The main alternative to this idea had come from processual and behavioural archaeology with the notion that areas of cultural similarity reflected areas of high social interaction (Hodder 1982 p. 11). *Hodder, I. 1982 Symbols in Action Cambridge: Cambridge University Press* 

**Student Writing:** Defining the extent and nature of cultural groups in the past was very important to archaeologists working at the beginning of the 20th century, but by the 1950s it had become clear that cultures did not always equal ethic units. The main alternative to this idea had come from processual and behavioural archaeology, which suggested that similarities in material culture did not necessarily identify a cultural group (Hodder 1982). *Hodder, I. 1982 Symbols in Action Cambridge: Cambridge University Press*

Sangiumvibool, P & Chonglerttham, S. (2016). Performance based budgeting for continuing and lifelong education services: The Thai higher education perspective. *Journal of Higher Education Policy and Management*, 39 (1); 58 – 74.

Sangiumvibool, P & Chonglerttham, S. (2016) analyzed the importance of performance-based budgeting. The study focused on the factors influencing the budgetary decision-making process. The author explained that the Thai government had implemented budget reforms in higher education sector in two different phases. The first phase is a non-financial phase and the second phase is a financial phase. As part of these reforms, the Thai government had enforced performance – based budgeting system. Under the new budgeting system, the administrators had to consider the budget expenditure and should ensure that they are consistent with the university's objective. The factors identified for the study were student head count, educational projects and programs, number of faculty, graduate students and administrative staff. The study found that student head count, economic conditions or political influence had no direct influence on Thai universities' budgetary expenditure, but the public university had to rely on government funding. The author suggested that the implementation of performance-based budgeting system should reduce the managerial costs on budgetary revision process during a year.
